To lend money to, and use its credit to assist, its officers and employees in accordance with Florida Statute S607.141;

To make donations for the public welfare or for charitable, scientific, or educational purposes;

To pay pensions and establish pension plans, profit sharing plans, stock bonus plans, stock option plans, and other incentive plans for any or all of its directors, officers and employees and for any or all of the directors, officers, and employees of its subsidiaries;


