

ARTICLES OF INCORPORATION
OF

The undersigned incorporators deliver these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act, and hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the corporation shall be PARMELE CONSTRUCTION, INC. The principal place of business of this corporation shall be 1648 Poe Ave., Orlando, FL 32806 and the mailing address of the corporation shall be the same.

ARTICLE II
CORPORATE PURPOSES, POWER AND RIGHTS


