ARTICLE ONE - NAME

The name of this corporation is: HMS Steakhouse of Port Richey, Inc.

ARTICLE TWO - DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of the date of filing of these Articles of Incorporation.

ARTICLE THREE - PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

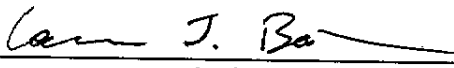
ARTICLE TEN - BYLAWS
