AccessRd.com, Inc., a corporation organized and existing under the laws of State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:

1. The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on August 26, 1999.
2. The amendment to the existing Articles of Incorporation being effected hereby is to delete in its entirety Article I of the Articles of Incorporation as of the date hereof, and to substitute in its place the Article set forth below.
3. As amended below, Article I of the Articles of Incorporation has the sole effect of changing the Corporation's name from "AccessRd.com, Inc." to "AccessLife.com, Inc." The Amendment to the existing Articles of Incorporation being effected hereby will make no changes in the current capital structure of the Corporation.
4. This amendment to the Articles of Incorporation was recommended to the shareholders of the Corporation by unanimous written action of the board of directors of the corporation on April 14, 2000 and was approved on April 14, 2000 by the written consent of the Corporation's sole shareholder as required by Section 607.1003, Florida Statutes and in compliance with the requirements of Section 607.0704, Florida Statutes.
5. These Articles of Amendment of the Articles of Incorporation shall be effective immediately upon filing by the Secretary of State of the State of Florida, all required taxes and fees having been paid, and thereafter the name of the Corporation shall be "AccessLife.com, Inc." and Article I of the Articles of Incorporation of the Corporation shall read as follows:

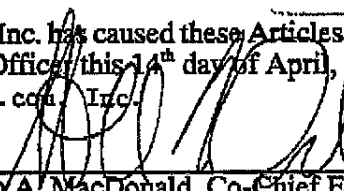

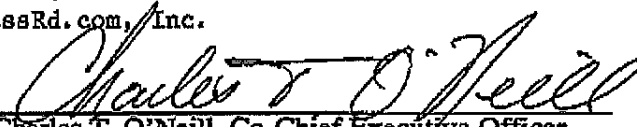
