OF

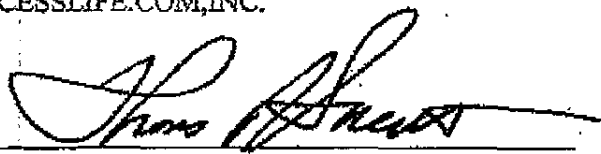
ACCESSLIFE.COM, INC.
