ARTICLES OF INCORPORATION
OF

L & A STANDARD HOMECARE AND CUSTODIAL SERVICES, INC.

In compliance with the requirements of F.S. Chapter 603, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is L & A STANDARD HOMECARE AND CUSTODIAL SERVICES, INC.,

ARTICLE II

The existence of the corporation shall begin on August 24, 1999.

ARTICLE III
