Article I.

Name

The name of the Corporation is Brennan Developments, Inc.

Article II.

Duration

The term of existence of the Corporation is perpetual.

Article III.

Purposes and Powers

Indemnification and Civil Liability


The Corporation shall indemnify each Director and Officer, including former Directors and Officers, to the fullest extent allowed by law.
