## ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

### ARTICLE I

The name of the corporation is **KEVIN MACWILLIAM**, P.A. herein after referred to as the "corporation."

### ARTICLE II

The initial street address of the principal office of this corporation is 2345 14<sup>TH</sup> Avenue, Suite 3, Vero Beach, Florida 32960. The Board of Directors may from time to time move the principal office to any other address in Florida.
