# ARTICLES OF INCORPORATION OF CREATIVE ZONE, CORP.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby organizes and incorporates a corporation under the laws of the State of Florida.

#### ARTICLE I. NAME

The name of the corporation is CREATIVE ZONE, CORP ..

#### ARTICLE II. NATURE OF BUSINESS
