Pursuant to the provisions of section 607.1006, Florida Statutes, Zappa Acquisition Corporation, a Florida corporation, adopts the following articles of amendment to its articles of incorporation:

**FIRST:** Amendment adopted:

Article I is hereby amended to change the name of the corporation to **Net Commerce Group, Inc.**

**SECOND:** Amendment adopted:

Article IX is amended by deleting the present language and inserting the following:


These Articles of Incorporation may be amended in the manner provided by law.
