# ARTICLES OF INCORPORATION OF FREMAR MACHINERY CORPORATION

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE 1: NAME
