The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

EFFECTIVE DATE

**ARTICLE I:** The name of the corporation is SACKETT PROPERTIES, INC.

**ARTICLE II:** The corporation shall exist for perpetuity commencing on the date of execution of these Articles.
