ARTICLE I

Name

Duration

This corporation shall have a perpetual existence, commencing on the date these Articles are filed with the Secretary of State.

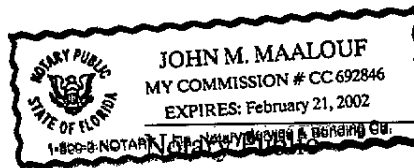
