ARTICLES OF INCORPORATION OF SCHULTZ & LANDOLINA, P.A.

SLONETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned incorporator, for the purpose of forming a professional corporation under the Florida Business Corporation Act and the Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is **SCHULTZ & LANDOLINA**, **P.A.**, hereinafter referred to as the "corporation".

ARTICLE II

The initial street address of the principal office of the corporation is 900 South Federal Highway, Suite 322, Stuart, Florida 34994. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE III

The duration of the corporation is perpetual.

ARTICLE IV
