**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a professional corporation under the Florida Business Corporation Act and the Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is **SCHULTZ & LANDOLINA, P.A.**, hereinafter referred to as the "corporation".

ARTICLE II

The initial street address of the principal office of the corporation is 900 South Federal Highway, Suite 322, Stuart, Florida 34994. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE III

The duration of the corporation is perpetual.

ARTICLE IV

The sole and specific purpose for which the corporation is organized is to render professional services of attorneys at law, and to do such things as are incidental to the purpose of the corporation or necessary or desirable in order to accomplish the purpose.

ARTICLE V

The aggregate number of shares which the corporation is authorized to issue is Ten Thousand (10,000) shares of common stock. Such shares shall be of a single class and have a par value of One Dollar (\$1.00) per share.

ARTICLE VI

The street address of the corporation's initial registered office is 900 South Federal Highway, Suite 322, Stuart, Florida 34994. The name of the corporation's initial registered agent at that office is Owen Schultz.

ARTICLE VII
