ARTICLE I.

NAME

The name of this corporation is Frederick T. Feaster, M.D.,
Inc.

ARTICLE II.

PRINCIPAL OFFICE

ARTICLE III.

DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of

ARTICLE IV.

PURPOSES

This corporation may engage in any activity or business per-

CAPITAL STOCK

AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE X.

BYLAWS


The initial Bylaws shall be adopted by the Board of Directors. The power to alter, amend, or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the shareholders.
