The undersigned for the purpose of forming a Corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the Corporation is: N.C. S. Pinnacle Corp.

ARTICLE II

The term of the Corporation shall be perpetual.

ARTICLE III


