

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation

ARTICLE I NAME:

The name of the corporation shall be CITRUS TITLE LOANS, INC.

ARTICLE II PRINCIPLE OFFICE:

The principle place of business and mailing address of this corporation shall be: 8707 Pampa Way, Port Richie, FL 34668. The Board of Directors may from time to time move the principal office to any other address in Florida.

No shareholder of the corporation may sell or transfer his stock in this corporation until the same shall have been approved, at a stockholders' meeting, exclusive of the stock proposed to be sold. The shares of stock proposed to sell or transfer his shares may not be voted or counted for any purpose at said meeting.


