THE UNDERSIGNED, acting as sole incorporator of **YREN DAH BAY PROPERTIES INCORPORATED** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the corporation is YREN DAH BAY PROPERTIES INCORPORATED.
