We are the accounting firm for C & D of Southwest FL, Inc. and we are writing to request your assistance with the corporation listed above and the year 2000 Uniform Business Report.

To begin with, the business location and mailing address changed at the beginning of February 2000. Unfortunately, C&D did not know to contact the Division of Corporations with this move.
