The undersigned, acting as incorporator of Core Net Group Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

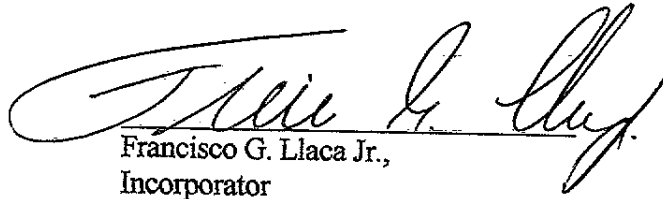

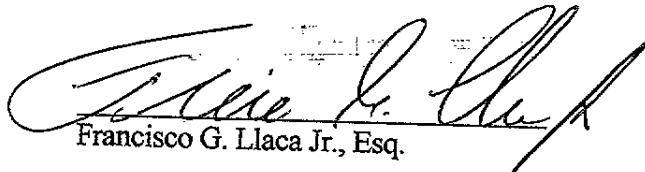
