#### ARTICLES OF INCORPORATION

OF

#### EMERALD COAST CONTRACTORS, INC.

The undersigned Incorporator to these Articles of Incorporation, a natural person, competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

#### ARTICLE I. CORPORATE NAME

The name of this corporation shall be EMERALD COAST CONTRACTORS, INC.

#### ARTICLE II. INITIAL PRINCIPAL OFFICE

The street address, and the mailing address of the principal office of the Corporation shall be: 3236 Creekwood Drive, Cantonment, Florida 32533. The Board of directors from time to time may move the principal office to any other address in the State of Florida.

#### ARTICLE III. CAPITAL STOCK


