ARTICLES OF INCORPORATION

OF

CHARIS ARTS, INC.

ARTICLE I - NAME

The name of this corporation is Charis Arts, Inc. (hereinafter referred to as the "Corporation").

ARTICLE II - DURATION

The Corporation shall exist perpetually, commencing on the date of filing of these Articles with the Department of State.
