ARTICLES OF INCORPORATION

OF

BEATTY'S Art & Frame, Inc

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

ARTICLE I

The corporate name for the corporation (hereinafter called the "corporation") is Beatty's Art I frame, Inc.

ARTICLE II

The street address, wherever located, of the principal office of the corporation is:

The number of shares that the corporation is authorized to issue is 7500, all of which are without par value and are of the same class and are Common shares.

In addition to the above purpose, the corporation shall have all of the general powers granted to corporations organized under the Florida Business Corporation Act, whether granted by specific statutory authority or by construction of law.

The corporation shall, to the fullest extent permitted by the provisions of the Florida Business Corporation Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all expenses, liabilities, or other matters referred to in or covered by said provisions, and indemnification provided for herein shall not be deemed exclusive of any other rights to which

those indemnified may be entitled under any Bylaw, vote of shareholders or disinterested directors, or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.
