Dear Sir or Madam:

I recently checked to find out why I haven't received my packet for renewing my corporations. One corporation is listed under: Judith Stern Consulting, Inc. and the FEI number for that corporation is: 650412684 and the second corporation is: Multimedia Response Communication, Inc. and the FEI number is: 650951396. What I uncovered was that my prior bookkeeper, who was fired last February, did submit Judith Stern Consulting, Inc for renewal, however listed the wrong address. My address at that time was 213 Southeast Eighth Street, Fort Lauderdale, Florida 33316. However, your records reflect Southwest Eighth Street, which explains why nothing was forwarded to my newer address. Simultaneously, I prepared a check for Multimedia Response Communication, Inc. for renewal and change of address from Davie, Florida to Fort Lauderdale, Florida. Both renewals reflect having been submitted on or about January 15, 2002. Upon firing of the bookkeeper, she deleted my banking files and cancelled checks and bank statements were destroyed, as well.


With the belief that my corporate records were properly renewed, I have continued to obtain occupational licenses in the City of Fort Lauderdale, and file my federal tax returns under each corporation. Therefore, I am asking for consideration of reinstatement by submitting a check for \$300 for review of Multimedia Response Communication, Inc. as well as my check of \$150 for renewal of Judith Stern Consulting, Inc.
