ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I
NAME

The name of the corporation shall be:

ARTICLE II
TERM OF EXISTENCE

The period of duration of the corporation is perpetual.

ARTICLE III
PURPOSE

The purpose or purposes for which the corporation is organized are to engage in any activity or business of medicine permitted under the laws of the United States and of this state.

ARTICLE IV
CAPITAL STOCK

Authorized Shares.

Number. The aggregate number of shares that the corporation shall have the authority to issue is 1000 shares of Capital Stock with a par value at One Dollar (\$1.00) per share.

Initial Issue. 500 shares of the Capital Stock of the corporation shall be issued for cash at a par value of One Dollar per share.

Stated Capital. The sum of the par value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

No classes of stock. The shares of the corporation are not to be divided into classes.

No shares in series. The corporation is not authorized to issue shares in series.

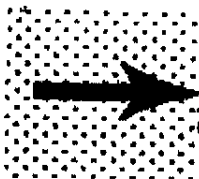
ARTICLE IX
