ARTICLES OF INCORPORATION OF

DENNIS KELLY PHOTOGRAPHY, INC.

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

<u>Name</u>

The name of this corporation shall be:

DENNIS KELLY PHOTOGRAPHY, INC.

ARTICLE II

Business and Purposes

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act.

ARTICLE III Capital Stock

A. The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 1000 shares of common stock with a par value of \$1.00 per share. Each share of said stock shall entitle the holder thereof to one vote at every annual or special meeting of the stockholders of this corporation. The consideration for the issuance of said shares of capital stock may be paid, in whole or in part, in cash, in other property (tangible or intangible) or in labor or services actually performed for this corporation, at a fair valuation to be fixed by the Board of Directors. When issued, all

shares of stock shall be fully paid and nonassessable.

This corporation shall have perpetual existence.

ARTICLE V Principal Place of Business

The street address of the initial principal office, and if, different, the mailing address of the corporation, shall be 317 Barbara Circle, Belleair, Florida 33756.

ARTICLE VI

Registered Office and Registered Agent

The initial registered office of this corporation shall be located at 317 Barbara Circle, Belleair, Florida 33756, and the initial registered agent of this corporation at such office shall be DENNIS KELLY. This corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE VII Board of Directors

The Board of Directors of this corporation shall consist of not less than one (1) nor more than five (5) members, the exact number of directors to be fixed from time to time by the stockholders or the by-laws. The business and affairs of this corporation shall be managed by the Board of Directors, which may exercise all such powers of this corporation and do all such lawful acts and things as are not by law directed or required to be exercised or done only by the stockholders. By-Laws

A.
