ARTICLES OF INCORPORATION
OF

WesBry-AusBay, Inc.

The undersigned, FRANK H. FEE, III, competent to contract, for the purposes of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such Corporation:

- FIRST: The name of the proposed corporation is WesBry-AusBay, Inc.
- SECOND: The Corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.
- THIRD: The total number of shares of stock which the Corporation shall have authority to issue is Five Thousand (5,000) shares, which shall be Common Stock. Par Value - \$1.00 per share.
- FOURTH: The amount of capital with which the Corporation will begin business is \$500.00.
- FIFTH: This Corporation is to exist perpetually.
- SIXTH: The Corporation's principal office and mailing address is 401 South Indian River Drive, Fort Pierce, Florida 34950.


