ARTICLE I

CORPORATE NAME

The name of the Corporation shall be: Pro Webcast, Inc.

ARTICLE II

NATURE OF CORPORATE BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation shall be to engage in any and all lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time shall be thirty million (30,000,000) shares of common stock having a par value of one (\$1.00) dollar per share.

ARTICLE VIII

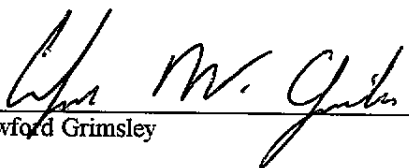

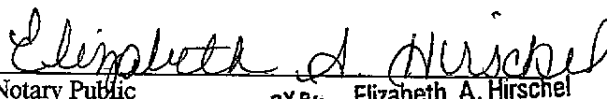

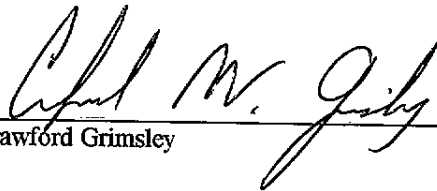
