ARTICLES OF INCORPORATION OF

Perfumes 2000.com, Inc.

TALLANIAS EN ST. 17

The undersigned incorporators, being competent to contract, subscribe to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be Perfumes 2000.com, Inc., whose principal address of this corporation is 1805 Siesta Drive, Sarasota, FL 34239.

ARTICLE II - BUSINESS AND ACTIVITIES
