ARTICLES OF INCORPORATION SECURE AM 10:01

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of the corporation is D. H. M. Restaurants, Inc., and the principal place of business shall be located at 2227 Ipsden Drive, Orlando, Florida 32837.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
