# ARTICLES OF INCORPORATION OF SUNSHINE ENTERPRISES ALTAMONTE, INC.

ARTICLE I. NAME

The name of this corporation is:

SUNSHINE ENTERPRISES ALTAMONTE, INC.

ARTICLE II. PURPOSE

This corporation is organized for the following purposes:
