NAME**

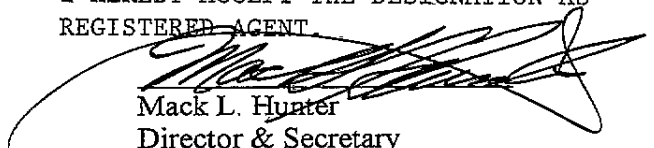
