Dear Division of Corporations Office:

Pursuant to our telephone conversations in last month and today with members of your staff, we are requesting a review of the documentation included with this letter. Also, please refer to your file for the documents mentioned in this letter.

In September 1999 we submitted form SS-4, the Application for Employer Identification Number (EIN) and form 2553, the Election by a Small Business Corporation. Both of these forms show the address of record as 2901 S. Bayshore Drive, Suite 7e, Miami, FL 33133. We were assigned the EIN of 65-0948669.

In February, 2000 an accountant retained by ANIP Enterprises, Inc. (no longer employed by the accounting firm) submitted the 2000 Uniform Business Report, (UBR), and our check for the \$150.00 fee. You will note the accountant filed using the incorrect address in submitting this form and fee.

Consequently, when your office requested the Federal Employer Identification (FEI) number, by way of your letter of March 15, 2000, it was mailed to the wrong address of record. Further, in your March 15 letter there is no clarification or explanation that the EIN and FEI is actually the same number. We were not notified again until your letter of July 24, 2000 noting the incorrect mailing address.

At this time we are re-submitting our request for the proper identifying number known as the Federal Employer Identification (FEI) number, the Employer Identification Number (EIN) and the Tax Identification Number (TIN). Due to the problems with delayed and misplaced correspondence, which include several Uniform Business Reports stating we were assessed a late fee, we are requesting a waiver of any additional fees or penalties.
