ARTICLES OF INCORPORATION

OF

PHOTOS AND ART BY MARIA L. DRUMM, INC.

The undersigned, an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is Photos and Art by Maria L. Drumm, Inc.

SECOND: The street address, wherever located, of the principal office of the corporation is 7711 Eagle Flight Lane, Fort Myers, Florida 33912. The mailing address for the corporation is the same.

THIRD: The number of shares that the corporation is authorized to issue is 100 (one hundred), all of which are a par value of 1 (one) dollar each and are of the same class and are Common shares.

FOURTH: The street address of the initial registered office of the corporation in the State of Florida is 7711 Eagle Flight Lane, Fort Myers, Florida 33912.

SEVENTH: The officers of the corporation shall be as follows:

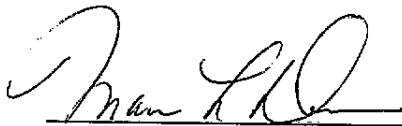

NINTH: The purpose for which the corporation is organized is to create photos and art for retail.

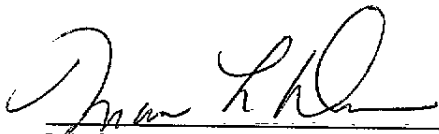
TENTH: The duration of the corporation shall be perpetual or until it is dissolved.
