The power to adopt, alter, amend, or repeal By-laws shall be vested solely in the shareholders.

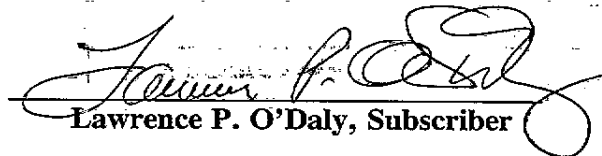

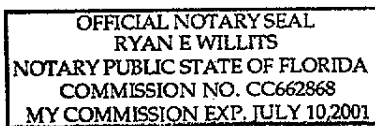

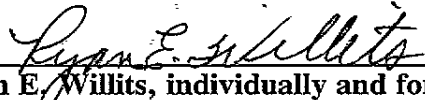
