**ARTICLES OF INCORPORATION  
OF  
BULLSEYE PAINTBALL PRODUCTIONS, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the Corporation is: BULLSEYE PAINTBALL PRODUCTIONS, INC.

**ARTICLE II - DURATION**

The duration of the Corporation is perpetual.

**ARTICLE III - PURPOSE**

The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares which the Corporation is authorized to issue is 100 shares of common stock, 50 shares voting and 50 shares non-voting. Such shares shall be of a single class and shall have a par value of \$.10 per share and shall be designated as voting or non-voting.

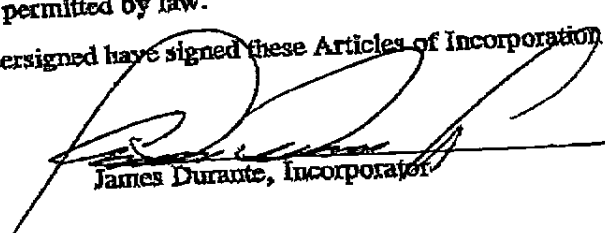
**ARTICLE X - COMMENCEMENT OF CORPORATE EXISTENCE**
