Article I - Name

The name of this corporation is **Muhammad Corporation**, and the corporations principal office and mailing address of the corporation shall be **582 Andrew Street, S.E., Palm Bay, Florida 32909**.

Article II - Duration

This corporation shall exist perpetually. The date of commencement of corporation shall be **August 23, 1999**.

Article III - Purpose

This corporation is organized for the purpose of engaging in any business activity permitted under the laws of the United States and the State of Florida.

Article IV - Capital Stock

This corporation is authorized to issue **1000** shares of **\$1.00** par value common stock.

Article V - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


Article XII - Amendment

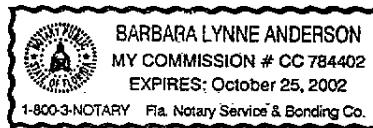


