The undersigned incorporator, hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the Florida Business Corporation Act and in accordance with the laws of the State of Florida, hereby adopts the following Articles of Incorportion.

ARTICLE I

The name of this corporation shall be Summa Liber, Inc. The effective date of incorporation shall be August 20, 1999.
