## Articles of Incorporation of Baskets, Etc. by Maryann Rapisarda, Co.

The undersigned natural persons, acting hereby as Incorporators for the purpose of forming a corporation for profit under the provisions of Section 607, Florida Business Corporation Act of the Florida Statutes, do hereby adopt the following Articles of Incorporation:

Name of Corporation, Principal Office and Mailing Address
