The undersigned subscriber to these Articles of Incorporation, hereby forms a corporation under the Florida General Corporation Act.

ARTICLE I

The name of the corporation is: eztech.com, Inc.

ARTICLE II

The duration of the corporation is perpetual and the purpose is to provide computer services.

ARTICLE III

The principal office and mailing address is:

ARTICLE IV

The corporation is authorized to have outstanding one class of stock, designated as Common Stock. The maximum numbers of shares of stock is 100 of a parvalue of \$1.00 per share. Holders of Common Stock are entitled to one vote per share with no
