# ARTICLES OF INCORPORATION PMIC, INC.

The undersigned does hereby subscribe to, acknowledge and files the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### <u> ARTICLE I - NAME</u>

The name of this corporation is PMIC, INC.

#### ARTICLE II - PURPOSE
