The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby for a Corporation for profit under Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is **DIDACHE NETWORK, INC.**

ARTICLE 2 - PURPOSE OF CORPORATION

The purpose of the corporation is to benefit and enrich the lives of individuals through the means of education and to provide distribution of educational content worldwide, through the collaboration of various individuals and organizations.
