## **ARTICLES OF INCORPORATION**

## B. J. DIXON ELECTRIC COMPANY, INC.

The Undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

#### **ARTICLE 1.0 NAME AND ADDRESS**

The name of the Corporation is: B. J. Dixon Electric Company, Inc.. The principal office and mailing address is 4681 Highway Avenue, Jacksonville, Florida, 32254.

#### **ARTICLE 2.0 DURATION**

The duration of the Corporation is perpetual.
