To: Never Quit Enterprises, Inc.

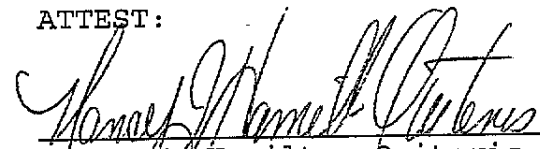
