OF

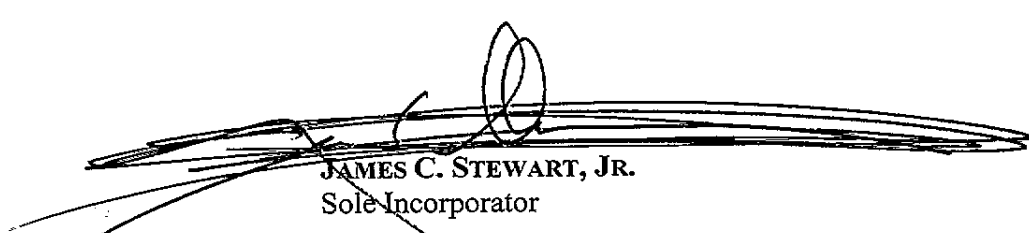
