
ARTICLE VIII - INDEMNIFICATION

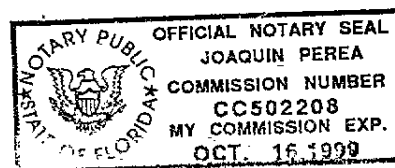


