ARTICLE I - NAME

The name of this corporation is ELIZA CLASS, INC. located at 6090 N.W. 186TH STREET, #15-304, MIAMI, FLORIDA 33015.

ARTICLE II - DURATION

The Corporation shall have perpetual existence.
