



Pursuant to the provisions of Section 607.1007, *Florida Statutes*, the following constitutes the amended and restated Articles of Incorporation of HOTEL DISCOUNTS NETWORK CORP.

### Section 1 -Name and Background

Hotel Discounts Network Corp. is a corporation organized and existing under the Florida Business Corporation Act, under document number P99000079563, filed in the office of the Secretary of State on September 8, 1999.

### Section 2 — Certification

Pursuant to Section 607.1007(4), Florida Statutes, Hotel Discounts Network Corp. hereby certifies that the amendment and restatement of the Articles of Incorporation required shareholder approval. By written action dated July 27, 2000, the Board of Directors recommended, and all of the Shareholders unanimously approved, the following amendment and restatement of the Articles of Incorporation of Hotel Discounts Network Corp.:

## **ARTICLE I - NAME**

The name of the corporation shall be Hotel Discounts Network Corp.

### **ARTICLE II - DURATION**

The corporation shall exist perpetually.

### **ARTICLE III - PURPOSE**

The corporation is organized for the purpose of transacting any or all lawful business for which corporations may be engaged in under Chapter 607, *Florida Statutes*.

### ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue 10,000,000 shares of common stock, no par value.

# ARTICLE V - REGISTERED OFFICE AND AGENT, <u>AND CORPORATE ADDRESS</u>

A. The corporation shall have no more than nine (9) directors. The number of directors may either be increased or diminished from time to time by the By-Laws but shall never be less than one (1).

# <u>ARTICLE VII - BY-LAWS</u>

### ARTICLE VIII – NO PRE-EMPTIVE RIGHTS

No holder of shares of the corporation of any class now or hereafter authorized has any preferential or pre-emptive right to subscribe for, purchase or receive any shares of the corporation of any class now or hereafter authorized, or any options or warrants for such shares, which may at any time be issued, sold or offered for sale by the corporation.

### **ARTICLE IX - INDEMNIFICATION**

The corporation shall indemnify any officer or director or any former officer or director to the fullest extent permitted by law.

## ARTICLE X - AMENDMENT

The corporation reserves the right to amend the Articles of Incorporation in the manner provided by law.

# Section 3 - Effective Date of Amendment

The effective date of the Amended and Restated Articles of Incorporation of Hotel Discounts Network Corp. set forth herein shall be the date of filing of the Amendment and Restatement of Articles of Incorporation with the Secretary of State of the State of Florida.
