Pursuant to the provisions of Section 607.1006 of the Florida Statutes, Hotel Discounts Network Corp., a corporation organized and existing under the laws of the State of Florida, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Section 1 - Name
